Selectmen's Report

To the citizens of the Town of Chilmark

After another busy year, I'll attempt to give a synopsis of the Selectmen's duties. Bill Rossi, Warren Doty and I have worked with Tim Carroll and the entire town hall staff to the best of our abilities.

We extend a warm welcome to Ellen Biskis as our new Town Accountant. After a vigorous regional search we interviewed five applicants, and Ellen Biskis was selected. Ellen comes to her job with impeccable credentials. Ellen and husband Taurus (a Chilmark Volunteer Fireman) have three wonderful kids. The town is lucky and we welcome her work ethic and great disposition.

Warren, as the lead Selectmen, to the Harbor Advisory Committee, Bill, me, the Harbormaster Dennis Jason as well as some members of the community worked together for the second phase regarding the gas dock, transient slips and charter dock. We have a fixed pier for the gas dock, a fixed and floating pier for the transient slip and hope to repair the charter dock. We hope this will suffice to solve the retrofit issues.

In The Shellfish Department, Isaiah Scheffer, Shellfish Constable, has noted continued effort on mussel propagation, increased efforts for farming oysters, renewed catching of wild oysters in Tisbury Great Pond, and, most importantly, one of the best years for bay scallops Chilmark has had in many years. Mother Nature may have assisted, but hats off to Isaiah and the MV Shellfish Group.

The USCG Boathouse Project continues. Although the boathouse is larger than we had hoped, it is smaller than originally planned. They have lessened the height by approximately two feet and worked on the width. Now, if we could assist the USCG to start their project in the fall (our off-season) it would lessen this major undertaking.

Thank you, Frank Fenner, for completing the final four months of your Selectmen's duty of 2012. His twelve years of sound judgment and expertise in all areas, especially in the building trades, was invaluable. We recognize Frank's desire to step back but we welcome his opinions and suggestions in the future.

There are many issues still on Chilmark's plate ranging from school repairs, beach issues, interactions between various boards, to Tri-Town Committee meetings, etc. Warren, Bill and I are willing to accept this responsibility with the help of others, if you so desire.
