The Selectmen and I met with our MIIA Account Executive Friday at 1 PM. We are exploring changes to our insurance coverage. It is essential that you provide the following information by the end of this week please.

POLICE

Make a list of all equipment in each police cruiser that cost more than \$250. Make, Model and serial numbers for things like RADAR, LIDAR, cruiser cam, Breathalyzers, long guns, portable computers, etc.

FIRE

Make list of all equipment on all fire apparatus that cost more than \$250. Make, Model and serial numbers when possible. Defib, IR Camera, CO/multi gas detector, radios, etc.

LIBRARY

Make a list of the artwork valued at more than \$2,500. Give us an estimate value of the book, cd, dvd, tape, etc collection.

HARBOR

Give us the make model and vin of your boat and motor. Make a list of all equipment in the Harbor Office that cost more than \$250.

SHELLFISH

Give us the make model and vin of your boat and motor. List any specialized equipment onboard, including any electronics over \$250.

HIGHWAY

Make a list of all power equipment that cost more than \$250. Make, Model and serial numbers (when possible).
