Dear Staff

At their last meeting the Selectmen discussed changing the biweekly payroll day from Wednesday to every other Thursday. The Selectmen asked me to inform you of this potential change.

Every year there are 3 or 4 Monday Holidays that interfere with payroll, leaving a short window to complete the process. This past three day holiday weekend was preceded by a PC failure on Thursday that Educomp was unable to correct in time to transmit the payroll. Earlier this year we have suffered lighting strikes and power failures that could have prevented the timely transmission of payroll.

In order to make sure that payroll is out on time every time, this one day shift in paydays is necessary. We are planning on implementing this change on April 11 by moving the payday to April 12. This does not change the payroll due dates.

Please send us your thoughts or concerns. The Selectmen will be voting on this January 17th; at their next meeting.
